PUBLIC COMMENTS

James Fisler with Mesa Water District addressed the board regarding his qualifications for the OC LAFCO Regular Special District Member Seat. CSDA Board of Directors Election 2019

GM Deutsch reminded the Board that Trustee Rivers is running for a seat on the CSDA Board of Directors. There are a total of seven candidates currently running.

GM Deutsch briefly discussed his desire to dedicate the new niche feature at El Toro Memorial Park in honor of Trustee Maureen Rivers. He would also like to recognize, in some way, the contribution of Kirk Hendricks, who was responsible for the design of the niches and passed away while working on the project. GM Deutsch would like to have a dedication ceremony at the next CAPC Local Area Meeting which the District is hosting here at El Toro Memorial Park on September 19th from 10 a.m. to 1 p.m. Vice Chair Hatch asked if there are plans for additional landscaping around the perimeter of the new niche feature as it looks quite stark right now. GM Deutsch said that there will be. Landscaping is one of the last things to be done on the project.

COMMITTEE REPORTS

Finance and Investment Committee Meeting, June 11, 2019

A. 2019-20 District Fee Review and Adoption by Resolution No. 2019-06

Trustee Nelson explained that the Finance and Investment Committee met on June 11th and one of the items discussed was a review of the Master Fee Schedule. Each year staff goes through a process to determine if any of the fees need to be revised based on several factors, including comparable interment space fees in other Orange County cemeteries,

Consumer Price Index percentages, current staff labor rates, the District Overhead Rate, and benefit percentages. There are basically three kinds of fees. They are: the Endowment Care Fees which are for the perpetual maintenance of the parks; Interment Service Fees, which are direct costs for conducting services; and Interment Space Fees, which are the costs charged for selling interment rights to a space. The Committee recommends a \$25 increase to all Endowment Care Fees; a three percent increase to all interment space fees with the exception of infant space which will remain at \$350; and some minor changes to some of the interment service fees. The District is also adding a new fee for additional groundskeepers to work weekend interment services. The fee will be \$230 for each additional groundskeeper per service.

of Vice Chair Hatch, seconded by Trustee Nelson and carried by a vote of 4-0 (Trustee Marroquin absent for the vote), adopted Orange County Cemetery District Resolution No. 2019-06, approving the District's Master Fee Schedule, to be effective August 5, 2019.

B. 2019-20 Fiscal Year Budget

GM Deutsch gave a PowerPoint presentation highlighting the various components of the 2019-20 Fiscal year budget. Topics of the presentation included General Fund Revenue Projections, General Fund Expense Projections, General Fund Capital Improvements, 10-Year Projections, and Designations for Additional Revenue. GM Deutsch estimates \$5.8 million in projected revenue and approximately \$3.9 million in expenses. The budget includes about \$1.2 million for capital improvements. The improvement projects for the upcoming fiscal year are the completion of the ongoing niche feature at El Toro Memorial Park with remaining costs of approximately \$215,000; the replacement of asphalt curbs, street repairs, and drainage adjustments at Santa Ana Cemetery at a cost of approximately \$600,000; and site assessments for the Gypsum Canyon Property at a cost of approximately \$400,000. Any additional revenue beyond expenses will be put toward development of the new cemetery and paying off the UAAL.

Each Cemetery Manager then presented information on current staffing, interment options available at that cemetery, history of interment services and space sales, upcoming capital improvements, and maintenance and operation projects.

Vice Chair Hatch asked if staff was excited about the cemetery. GM Deutsch replied that everyone is excited to get out on the property. Vice Chair Hatch commented on the low turnover for employees at the District, stating that it speaks highly of management.

BOARD COMMENTS

CSDA Board Planning Session, Newport Beach, June 26-27, 2019

Trustee Nelson explained that every three years they hold this meeting. Directors go to different work stations that cover varying topics and they can give their comments on the strategic plan.

ISDOC Quarterly Meeting, Fountain Valley June 27, 2019

Trustee Rivers attended and stated that she was surprised that none of the OC LAFCO candidates were present. The topic was on wastewater rates and regulation trends. Overall attendance was down.

ISDOC Executive Committee Meeting, Fountain Valley, July 2, 2019

Trustee Nelson stated that he spoke about the upcoming CSDA Annual Conference in Anaheim. He also mentioned that CSDA award nominations are due July 17th, and stated that electronic ballots for the CSDA election will be forthcoming.

There was some discussion on the GFOA Budget Award that the District recently received, largely due to the efforts of Brenda Manriquez. GM Deutsch stated that the original budget was 48 pages and with all the CAFR requirements included it jumped to 84 pages. For the Budget Award, GM Deutsch said that of the 51 Special Districts that received this award, our District is the only public cemetery district to apply and receive the award. Vice Chair Hatch asked if it is worth the extra work. GM Deutsch said, that like transparency, it is just another indication of good governance.

There was also a brief discussion with General Counsel Steve Quintanilla regarding development impact fees and if the state would allow us to collect fees from developers to offset the costs for services that will be needed because of the development.
