SUBJECT: Consent Calendar

In general, the Consent Calendar contains routine matters or matters that have already been discussed by the Board. It is adopted in total with a single motion and Board action. However, if any Board member or member of the public has questions or wishes to discuss an item further, it may be removed from the Consent Calendar and placed later in the agenda for discussion and action. The way to remove an item from the Consent Calendar is to request its removal, by agenda item letter, immediately prior to the adoption of the Consent Calendar. Members of the public may fill out a request to speak on the item they wish removed and the Board Secretary will note the item. No reason need be given with the request. Items pulled from the Consent Calendar are not discussed at the time they are pulled; they are scheduled for discussion immediately after action on the balance of the Consent Calendar.

The February 4, 2025 Consent Calendar contains the following items:

There are payments to Linnes Services for dirt hauling for El Toro (\$12,815.71) and asphalt removal & soil delivery to Santa Ana (\$24,897.35) in preparation for opening new interment sections. There is a payment to Eide Bailly for audit services for \$19,047. There is a payment to Meyers Nave (\$35,380.50) and Quintanilla & Associates (\$14,635) for legal services to support the litigation and general district business.
