Trustees Pass Resolution Reserving Land for Veterans Cemetery

At the Dec. 4, 2018 County of Orange Board of Supervisors Meeting, 283.3 acres of land near the junction of the 241 Toll Road and CA State Route 91 were conveyed to the District, with the stipulation that half of the developable land be set aside for a Veterans cemetery.

Since then, various consultants have been conducting site assessments on the property to determine how much of those 283 acres are actually developable. With the current geotechnical data, RJM Design Services has indicated that 231 acres is suitable for possible development with 108 acres for the public cemetery on the lower portion of the property and 108 acres for the Veterans cemetery on the upper portion of the land. The two cemeteries would share approximately 15 acres of common area making up the entrance to the grounds.

The Orange County Cemetery District is extremely grateful for the foresight of the Board of Supervisors in recognizing the urgent need to provide the residents of Orange County with this additional burial space. Our public cemeteries are often the only affordable option for county residents when the death of a loved one occurs. With casket space sold out at Anaheim Cemetery, and nearly gone at Santa Ana Cemetery, El Toro Memorial Park in Lake Forest has become the last and best option for County residents and will likely be sold out within 8 to 10 years. This land ensures that the needs of our communities will be well served into the future. The creation of a Veterans cemetery on the upper portion will finally give an eternal resting place within Orange County for our deserving Veterans and is long overdue.

To show the District's commitment to the development of the Veterans cemetery, the Orange County Cemetery District's Board of Trustees passed Resolution 2020-02 at the February 4, 2020 Board Meeting. The resolution designates half of the developable acreage for the creation of the Veterans cemetery and memorializes the District's compliance with the Supervisors' intent that land be reserved specifically for the Veterans. In addition, the new public cemetery will also have a designated area specifically for our Veterans as well as for service members who fought alongside U.S. forces as allies.

The District's Trustees understand the vital importance of

Extended Hours at El Toro Memorial Park Begin on March 8th

Sunday, March 8th marks the beginning of Daylight Saving Time. For visitors to El Toro Memorial Park that also means the start of extended visitation hours. Beginning on Sunday, March 8th, the grounds at El Toro Memorial Park will be open for visitation from 8 a.m. with the gates closing promptly at 7:00 p.m. Extended hours continue until Daylight Saving Time ends on Sunday, Nov. 1, 2020.

Visitation hours at Santa Ana Cemetery and Anaheim Cemetery are from 8:00 a.m. to 5:00 p.m. year-round. All three cemetery offices including the District Office are open Monday through Friday from 8:00 a.m. to 5:00 p.m. Offices are closed on the weekends.

PLEASE RESPECT CLOSING TIMES AND PLAN VISITS ACCORDINGLY

District staff and our gatekeepers respectfully ask that you please consider closing times when you visit the grounds. If you wish to stay for any length of time, please don't enter the park five minutes before the gates are to close and expect to be allowed to stay. All visitors to the parks should plan to exit the grounds at or before closing time so the cemeteries can be cleared and the premises locked in an efficient and timely manner. We greatly appreciate your cooperation in this regard.

this land and are intent on maximizing its best use for the benefit of County residents. The District is exploring options such as walking trails, a community chapel/meeting space, and continued cooperation with the Orange County Fire Authority and the Fire Departments for the City of Orange and the City of Anaheim to maintain access to the site for training purposes.

Once a clear strategy is in place for addressing the site’s geotechnical issues, a more definitive cost estimate can be

created. In the meantime, the District is exploring various financing options for the project. Over the last decade, the District has diligently saved for an expansion. By the end of this fiscal year, we expect to have about \$11 million set aside. Rough estimates show the first phase of the public cemetery development will cost around \$25 million.

The District is humbled with this opportunity and what it means for the families and veterans residing in Orange County. We look forward to making this dream a reality for all.

Flower Removal and Holiday Schedule

Every Wednesday, groundskeepers remove and discard flowers and decorations throughout all three cemeteries. Families are encouraged to remove their flowers or decorations on Tuesday night; you can then place the flowers back on the space on Wednesday afternoon. Please remember that the District policy only allows for two items to be placed on gravesites. This includes the in-ground flower vase and one other item. If gravesites exceed the number of allowed items, staff may remove and discard the excess items. Please do not leave items of great monetary or sentimental value on gravesites as the District cannot prevent theft.

The District permits the allowed two items of flowers and/or decorations to be left on gravesites during holidays or for special occasions, such as anniversaries, birthdays and for new interments. Please come to the cemetery office and let us know that you have a special occasion and request that the flowers and decorations be left on the space. We do ask that you empty the vase and place fresh water in the container every four to five days to eliminate mosquito breeding sources, which can cause serious health issues. Your cooperation in this regard is greatly appreciated.

In honor of Persian New Year, flowers At El Toro Memorial Park may be placed on Thursday, March 12th until Tuesday, March 31st. In honor of Easter, flowers at all three District cemeteries may be placed on gravesites on Thursday, April 2nd and should be removed by Tuesday, April 21st.

All District cemeteries are open for visitation seven days a week, year-round.

Anaheim & Santa Ana Cemeteries are open daily from 8:00 a.m. to 5:00 p.m.

El Toro Memorial Park in Lake Forest is open during the Fall and Winter months from 8:00 a.m. to 5:00 p.m. daily.

El Toro Memorial Park – Extended Hours

When Daylight Saving Time begins on March 8th El Toro Memorial Park will remain open until 7:00 p.m.

When Daylight Saving Time ends on Nov. 1st the park will close at 5:00 p.m.

Offices are closed on the weekends.
